## CHARITABLE DONATIONS POLICY

The Midwest Dream Car Collection is a museum committed to supporting causes that improve the quality of life for the residents of the Manhattan community and surrounding areas. The museum frequently makes donations of cash, goods, or services to local schools, civic groups, and church groups in the communities it serves. All parties requesting financial support from the museum must complete a Charitable Donation Request form. The completed form should fully explain the nature of the contribution being sought and include all requested documentation. The Charitable Donation Request form is available at the museum's front desk or request by email. All required documentation should be submitted to the museum following the directions provided below. Contributions Policy • The organization must also be a 501(c)(3) or non-profit organization. • Requests should be submitted at least 30 days prior to the event to give proper time to evaluate the request. • Complete proposals include a description of the organization and its mission. • Nonprofit organizations should submit their tax-exempt letters from the Internal Revenue Service with their contribution requests. • Complete proposals will be considered monthly by a committee. • Incomplete proposals or those with deadlines within 30 days of submission may not be considered. Preferential consideration is generally given to requests where the following apply: • The recipient is a local community organization in the Manhattan community and surrounding areas within a 60-mile range. • Money donated will be spent in the Manhattan community. • Money donated will benefit a significant group of people (as opposed to a single person). • The Museum receives recognition for its donations.

The museum does not make charitable donations to for-profit organizations. For-profit organizations seeking sponsorship may submit requests which will be evaluated by the museum on a commercial basis for the advertising and marketing benefit such sponsorships would provide to the museum. In order to accommodate contribution requests, the museum may choose to donate promotional items that could be used by the requesting party.
